

Representative Engagements



Prepared and measured builders risk delay claim on behalf of a real estate owner and developer exceeding \$50 million. The 368-unit complex was significantly impacted by a fire, just three months before opening the first phase of the building. Our team's construction experts assisted in quantifying the Hard Costs and Period of Delay, while our forensic accounting & claim experts prepared the claim and quantified the Loss of Rental Income and additional Soft Costs, such as Additional Financing Costs and Insurance Premiums.



Measured and prepared the builders' risk delay loss for a luxury lifestyle hotel in Dallas. This claim included "soft costs" (e.g., interest on carrying debt) in relation to the construction delay. This claim also calculated the loss due to delayed sale of condos (time value of money). This loss considered an extraordinary local sporting event (NBA Finals) during the delay that would have increased occupancy at the loss location.



Prepared the builders risk insurance claim for a large construction company following damage from Hurricane Harvey. Represented all insured parties named under the insurance policies, which included the general contractor, various subcontractors, the owners, the city of Memphis, Shelby County and the Public Building Authority. Complicating factors included the cost justification of construction practices taken to prevent further damage to the facility, as well as to expedite and mitigate the loss.



Prepared the Builder's Risk insurance claim for Encore Construction, following damage from Hurricane Harvey. Ankura prepared both the Hard Costs and Delay in Startup portions of the claim. Our construction professionals assisted in quantifying the Hard Costs and Period of Delay, while our forensic accounting & claim preparation experts prepared the claim and quantified the Loss of Rental Income and additional Soft Costs.



Ankura is aiding the owner of a 4-story apartment complex in Atlanta, GA, with a property damage claim after an August 2020 fire. The fire caused a total loss to part of the building and partially damaged other sections, with losses estimated at \$70 million. Ankura was involved early, helping with scope development and the initial schedule for rebuilding and remediation. This matter is ongoing. Ankura's services in this matter include: preparing property damage claim and providing claims advising; working with the general contractor and design team to document project progress and manage completion risks; holding regular meetings with all parties to address project progress and issues; providing monthly progress updates to owner and insurance adjuster; assisting in responding to adjuster questions.
